- CESD board of trustees priorities for 2024; search for new superintendent
  - Superintendent has announced his retirement, so currently searching for a replacement for a transition May/June. Survey was sent out and board has received input.
  - Alberta School Board Trustee meeting trustees, ministers, MLA's for yearly meetings
  - Preparation for Trustee Election in one year Oct 2025
  - Auditing of financials of CESD

Big focus on career preparation.

20min Principal's Report: Dean Nielsen, Kristina Rentz, Teri Sadek

- Key updates in policy, programing, communication, staffing
  - o Dean updated Ms Cunninham is leaving and currently looking to replace her careers role.
  - Dean spoke to Flex time (FLT). Estimated 75% use effectively and 25% not using it effectively.
    Rethinking FLT for next semester to make it more productive. More information will be shared at that time
- HSS results on Alberta Government and CESD surveys from early 2024
  - Dean summarized 100 page document with key points from survey: Strengths: a) relationships with parents, teachers, school b) academic growth specifically math c) career pathways d) student engagement. To work on: a) student engagement b) mentorship c) attendance
  - Asked our thoughts on how perception of engagement is up but actual presence in the school is not. Why and how might we change that. Do we need to?
